

**CHILDREN AND YOUNG PERSONS ACT 1963, s. 37**  
**L.A. Raeven Rules 2002**

**Application for a L.A. ARMY Licence.**

(Note--let is important that this form, fully completed, should be sent so as to reach the licensing authority not less than twenty-one days before the first performance for which the licence is requested, since the licensing authority may otherwise refuse to grant a licence.)

**PART I**  
(TO BE COMPLETED BY THE APPLICANT)

I hereby apply for a license under section 37 of the Children and Young Persons Act following the L.A. Raeven Rules, which are:

- \*(1) I WANT to become like HIM.
- \*(2) I WANT and I NEED to eat EXACTLY THE SAME as HIM, both in HOW MUCH and in WHA T I eat.
- \*(3) Together we need to decide WHA T to eat and the EXACT AMOUNT and WEIGHT .
- \*( 4) We HAVE TO CHECK that the amount of food we both have is EXACTLY the same.
- \*(5) I never have more food than him, in-fact I must try to have LESS FOOD than him.
- \*(6) If he tries to cheat I am angry and I have to PUNISH HIM.
- \*(7) We CAN NOT and DO NOT WANT TO CHOOSE which portion of food we have, neither one us can have CONTROL, so we have to flip a coin.
- \*(8) We have to make sure that the volume of liquid we drink is the EXACTLY the SAME using a spoon to be precise.
- \*(9) All food in liquid form such as soup, yoghurt, ice cream...we have to finish making sure that our bowls are COMPLETELY EMPTY if we don't agree or know which of us has left more in his cup, we have to feed each other.
- \*(10) I do not want to have large amounts, I only want LITTLE PIECES.
- \*(11) I DO NOT ACCEPT COLD FOOD which is supposed to be hot.
- \*(12) I DEMAND that servants bring all food and drink to me in MY TIME and I will SEND BACK ALL FOOD which arrives too quickly.
- \*(13) I am not allowed to pour more wine into the glass if we are NOT both COMPLETELY finished with the last one.

I understand that if a license is granted to me it will be granted subject to the restrictions and conditions laid down in the L.A.RAEVEN RULES 2002 and to such other conditions as the local authority or the licensing authority may impose under the said Rules.
